The Hon'ble Kerala Administrative Tribunal in its judgement in OA-910/16 and connected cases read 1st cited have clearly stated that "the posts in the category of Jr.HI Grade-I, JPHN grade -I and Staff Nurse Grade –I are declared to be State Cadre post and incumbents are eligible for getting transfer to their home district in accordance with their seniority and without adopting the norms for Inter District Transfer". The Government have also issued GO read 2nd cited in accordance with judgement above.

Accordingly the applications for General Transfer for 2017 was invited as directed by the GO read 3rd cited and final list was also published as per read 4th cited. The eligible applicants who have more than 3 year continuous service outside from their native/opted district have to be allotted to their respective districts, There were no sufficient applicants in proportion to be transferred in order to accommodate them. In the circumstance senior persons including those who were abstaining from the submission of application were found out through SPARK and transferred out from each district for considering the right of the seniors to get transfer to their native district as per General Transfer norms.

Aggrieved by this transfer order some of Junior Health Inspectors filed OAs before the Hon'ble Kerala Administrative Tribunal and some of them submitted representations to this respondent. The Hon'ble Tribunal vide various orders read 5th to 10th cited above directed this respondent to consider the representation of the applicants in Appeal Committee and pass orders after giving an opportunity to hear the applicants. In compliance of the order the applicants were heard in person on 13.09.17 and 14.09.2017 and the final decision of Appeal Committee is given below.
