As per the Government order read as Ist above, Government have restored the seniority of Smt. P.G. Geethamani Antherjanam, Deputy District Education and Media Officer, District Medical Office of (Health) Kollam as 16(A) in the list of officers for promotion to the post of Deputy District Education and Media Officer on the basis of judgement by the Hon'ble High Court of Kerala in WPC no. 26965/11/Dtd. 27/10/2011. On the basis of the above Smt. P.G. Geethamani Antherjanam was included in the field of choice of Department Promotion Committee (Lower) for the year 2015 and Departmental Promotion Committee which held on 1/1/16 had selected her and promoted as Deputy District Education & Media Officer.

Now Government have directed as per the Government letter 2nd paper above, that Smt. P.G. Geethamani Antherjanam had not get promotion in time due to administrative reason and hence Adhoc Departmental Promotion Committee may be convened to include Smt. P.G. Geethamani Antherjanam in the select list for the year 2011 and the seniority list of Deputy District Education & Media Officer may be revised accordingly. As instructed by Government Adhoc Departmental Promotion Committee (Lower) has met on 31/1/2019 and she has been included in the select list of officers for promotion to the post of Deputy District Education and Media Officers for the year 2011 on the basis of the revised seniority number ie. 16A.

In continuation to the above it is provisionally decided to reassign the seniority position of Smt. P.G. Geethamani Antherjanam in the seniority list of Deputy District Education and Media Officer for the period from 1.1.1997 to 31.1.2013 published vide order no. ES1/86257/12/DHS/Dtd. 16/5/2013 as 24 A in between Sri. Unnikrishnan Nair & Sri. Ibrahim K. who were holding rank number 24 & 25 respectively in the seniority list as detailed below.
