In the order read as 1st above, the Hon'ble Kerala Administrative Tribunal has directed the first respondent, Secretary, Health & Family Welfare Department to consider and pass orders on the representation submitted by the applicant Sri. Muraleedharan K.V., Junior Health Inspector Grade II after hearing the applicant.

As ordered by the Hon'ble Kerala Administrative Tribunal, the applicant was heard by the first respondent, Secretary, Health & Family Welfare Department.

The contention of the applicant is that his rank no. 454A in the seniority list referred 2nd above may be refixed, by considering the fact that he joined in the cadre of Junior Health Inspector Gr II on 16/11/2000, as those who joined in the said cadre after him are positioned above. In this connection, Government have given direction vide GO (Rt) 1781/2018/H&FWD dtd 1.6.2018 to refix the seniority of Sri. Muraleedharan K.V. in appropriate place in the seniority list above the directly recruited Junior Health Inspector Gr. II who were advised in between 22/11/2000 and 30/9/2002. As such a notice has been issued from this office vide referred as 4th above where in the seniority rank no. of the applicant Sri. Muraleedharan K.V. is reassigned as 49(B) instead of the existing Rank No. 454A. No appeals were received in this notice so far.

Hence the seniority position of Sri. Muraleedharan K.V., Junior Health Inspector Gr II is hereby reassigned in the seniority list of Junior Health Inspector Gr II for the period from 1/4/2000 to 31/10/2007 as detailed below.
