**ORDER No. ES3-36758/2015/DHS dated 20/09/2016**

The final seniority list of Staff Nurse Gr-I as on 01/11/1999 was published vide order read 1<sup>st</sup>. The subsequent seniority list of Staff Nurse Grade-II for the period from 07/07/1990 to 31/12/2002 was published vide order read 2<sup>nd</sup> and the incumbents bearing rank no 1 to 3459 in the seniority list read 2<sup>nd</sup> was promoted to the cadre of Staff Nurse Gr-I vide order read 3<sup>rd</sup>. Those incumbents who were on Leave Without Allowance during the promotion vide order read 3<sup>rd</sup> were promoted through subsequent orders upon their rejoining.

The preliminary seniority list of Staff Nurse Grade-I in this Department for the period from 10/11/2008 to 20/08/2013 (As on 31/12/2015) was published vide order read 4<sup>th</sup> inviting appeals from aggrieved parties regarding any corrections/anomalies etc. The appeals received in this regard have been scrutinized and after incorporating necessary amendments based on the appeals deserving merit, the final seniority list of Staff Nurse Grade-I in this Department for the period from 10/11/2008 to 20/08/2013 (As on 31/12/2015) is published herewith as detailed in **Annexure-A** appended. This seniority lists consists of the incumbents between rank no 1 to 3459 in the seniority list read 2<sup>nd</sup> and who have been promoted to the cadre of Staff Nurse Gr-I between the period from 10/11/2008 to 20/08/2013. Those incumbents who have already left this Department and

joined Medical Education Service consequent on abolition of Dual Control System have been excluded.

In respect of incumbents who joined as Staff Nurse Gr-I consequent on order read 3<sup>rd</sup>, their seniority has been arranged in the order of their seniority position in the cadre of Staff Nurse Gr-II in the order read 2<sup>nd</sup>. In respect of the incumbents who were on LWA during the issuance of order read 3<sup>rd</sup> and rejoined duty further between the period from 10/11/2008 to 20/08/2013, their seniority has been arranged from the date of their rejoining duty after LWA assigning the rejoining date as date eligible for promotion.
