As per the reference 1<sup>st</sup> cited, 43 Nursing Staff have submitted representations to rectify the anomalies occurred in the seniority list of Staff Nurse Grade-II (1978-1990), Staff Nurse Grade-II (1990-2002), Staff Nurse Grade-II (2003-2010), Staff Nurse Grade-I and Head Nurse published vide references 2<sup>nd</sup> to 6<sup>th</sup> cited respectively. The points raised in their request have been examined in detail with all connected service details and found certain anomalies, such as non inclusion of name, non consideration of Inter District Transfer and Leave without Allowances, correction of date of birth, correction in Rank No. etc.


