Smt.Shobha.K Junior Public Health Nurse has filed an original application for reassigning the Rank Nos. of 23 J.P.H.Nurse who secured Inter District Transfer . The points raised by the petitioner in the O.A have been examined in detail.

On verification of service particulars of the incumbents for the above purpose, it is noticed that rank no of 15 incumbents who secured Inter District Transfer in the entry cadre were not lowered in the seniority list of Jr.PHN and they were also seen promoted to the cadre of Jr.PHN. Gr. I on the basis of the wrong seniority position.

Inter District Transfer of DRB recruitees upon request can be granted only under the terms and conditions stipulated in G.O under referred. As per rule 27 Part II of KSS &SR and G.O under reference, no Inter District Transfer is possible without forfeiture of accrued seniority in the old district and the transferee will be the junior most in the new district. Accordingly the JPHNs who secured Inter District transfer from their recruited district are eligible to be reckoned their seniority only with effect from the date of joining in the transferred district. They are eligible to reckon their seniority only with effect from the date of joining duty in the transferred district.

In this circumstance, it is provisionally decided to reassign the rank No of the 15 incumbents, who obtained IDT to other district than from recruited district in the entry cadre, as detailed in Annexure A appended herewith. It is also decided to delete their ineligible ranks assigned to them.

Persons who are likely to be aggrieved by the above proposal may file appeal if any within 15 days from the date of publication of this notice. If objections are not received within the said period of time, this proposal will be finalised.

All District Medical Officers of Health are requested to circulate this notice among all medical officers concerned working under their jurisdiction. They are also requested to forward appeals if any received with in the date fixed.
