## ORDER NO. FWA4-550511/2017/DHS, DATED 13.10.2017

General Transfer 2017 of Junior Public Health Nurse Gr.I was implemented vide order 1st cited. Some incumbents had approached the Hon'ble Administrative Tribunal challenging the said orders. The Hon'ble Kerala Administrative Tribunal vide orders in various OAs read as 4,5,6 directed the DHS to examine the representations of the incumbents who had filed OAs.
