ORDER

The Director of Health Services as per the letter read above has reported that the validity of Medical Certificates issued by various Medical Officers namely Junior Consultants, Consultants, Senior Consultants and Chief Consultants etc has been controversial and that many department/institutions are not honouring the Medical Certificates issued by the Doctors under Speciality Cadre for the only reason that the designations of Medical Officers are not the same as they prescribed and hence requested to equate the different categories of doctors for issuing medical certificates.

Government have examined the matter in detail and are pleased to order that the following categories of Doctors in the Health Services Department are equated for the purpose of issuing medical certificates.

- 1) Junior Medical Consultants to Assistant Surgeon.
- 2) Medical Consultants to Civil Surgeon.
- 3) Senior Medical Consultants to Deputy Director of Health Services.
- 4) Chief Medical Consultants to Additional Director of Health Services.


