The following candidates who have been advised by the Kerala Public Service Commission, Thiruvananthapuram as per letter read above are temporarily appointed under rule 9(a) of KSSR in this Department as Radiographer Grade II in the scale of Pay 22200-48000 and posted to the institution noted against their names.

Due to the circumstances arose due to COVID-19 pandemic, the candidates are directed to report duty before the District Medical Officers concerned within 15 days of publishing of the posting orders failing which action will be taken to cancel the appointments. The candidates should produce the original certificates:-

- 1) to prove, educational qualification, Date of birth, Identity for verification.
- 2) Certificates of physical fitness obtained from a Medical Officer in Government Service not below the rank of Civil Surgeon/consultant
- 3) Original Non-creamy layer certificates.

The concerned district Medical Officer of Health should on behalf of the undersigned verify the above documents before permitting the candidates to join duty. Scanned copy of One time Verification certificate which includes the scanned image of photo and signature of the candidates is enclosed for the reference of District Medical Officer Health. The Photograph and the signature of the

candidate may be verified and the fact may be recorded on the copy of one Time Verification certificate and may be forwarded to this office.

If there is any discrepancy found, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith. After the candidate is allowed to join duty, the copy of identification certificate may be kept pasted in the service Book.

The Service book will be opened within one week from the date of joining duty and attested photocopy of the page containing name, address, finger print, Identification marks and qualification should be forwarded to this office along with annexure I received from the candidates for PSC & Police verification. The appointment shall be regularized only after the receipt of verification certificates from Kerala Public Service Commission and Police authorities.

The application for correction of Date of Birth, if any required should be made by the candidates within five years from the date of entry in services.

No separate appointment order is sent to the candidates. Hence they are requested to download the appointment order from the website www.dhskerala.gov.in.

The above posting placements are preferred on provisional basis due to covid-19 pandemic outbreak & will be reviewed as per Ltr.No.A3-246/2020/(H) H&FWD, Thiruvananthapuram dated 29/9/2020. The candidates have not any right or preferential claim for continuing in the station noted in this order.
