

**PROCEEDINGS OF THE ADDITIONAL DIRECTOR OF HEALTH
SERVICES(PH), THIRUVANANTHAPURAM.**

As per the Order read as first paper above, the Hon'ble Kerala Administrative Tribunal disposed the OA filed by Sri. Unnikrishnan. P., Health Inspector, Primary Health Centre, Anakkayam, Malappuram, directing the first respondent, Government to take a decision on Annexure 13 representation after hearing the applicant.

As directed by the Hon'ble Kerala Administrative Tribunal, representative of the 1st respondent heard the applicant on 06/11/2019. Government have taken into the consideration that the applicant's mother, an octogenarian was post cardiac survivor requiring prolonged medication and the applicant is due to retire on 31/05/2021. Therefore Government have ordered that the applicant is to be posted either at Primary Health Centre, Thiruvambadi or at Community Health Centre, Narikuni, if there vacancy is there to accommodate the applicant. If no vacancy is there as on the date of this order, he is to be accommodated in any other station more convenient to him. If there is no existing vacancy as such he is to be accommodated in the next arising vacancy either at Primary Health Centre, Thiruvambadi or at Community Health Centre, Narikuni. In the representation read as 3rd above Sri. Unnikrishnan the applicant request to post him at Primary Health Centre, Mukkom, Kozhikode in which vacancy of Health Inspector arose on 01/06/2020.

In the circumstances cited above, Sri. Unnikrishnan, Health Inspector Gr.II, Primary Health Centre, Anakkayam is hereby allotted Kozhikode District. The District Medical Officer of Health, Kozhikode will issue suitable posting orders to Primary Health Centre, Mukkom as per reference cited 3rd.
