The candidate appointed will come under the new pension scheme. The candidate should produce the following documents at the time of joining duty.

- 1) Original documents to prove the date of birth and Educational Qualification etc.
- 2) Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. The candidate should affix recent passport size photograph duly attested by the issuing officer.
- 3) Prescribed community certificate.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if her character and antecedents are found satisfactory on subsequent verification.

In the event of discharge from service for want of vacancies, the candidate may either register her name in the office of the Public Service Commission from where she was advised and get herself re-appointed on further advice by the Public Service Commission or she may wait for her turn for re-appointment to the post in the department in case she desire to continue as probationer in the posts from which she was discharged vide Government Circular Memorandum No.3737 Rule 1/90 P&ARD dated, 15/02/1991. The appointment is also subject to Rule 3(c) 7 General Rules of Kerala State and Subordinates Service Rules 1958.

Application for correction of date of birth if any needed should be made by the candidate within five years from the date of entry in service.
