**ORDER NO. EF2-100246/2017/DHS. DATED: 08/05/2020.**

As per the order read 1<sup>st</sup>, the State wise strength fixation between the posts of Lab Technician Gr.II and Gr.I was ordered considering the number of posts existed as on 16/12/18. As per order 2<sup>nd</sup>, the prescribed ratio between Lab Technician Gr.II & Gr.I has been retained as 1 : 1. After the issue of orders read 1<sup>st</sup>, 200 posts of Lab Technician Gr.II have been created in various situations across the state as detailed in Annexure-I appended. Accordingly it is found necessary to re-fix the ratio between Lab Technician Gr.II and Gr.I considering the post creations done since last strength fixation.

In the above circumstances the State wise/District wise strength between the post of Lab Technician Gr.II and Gr.I are hereby re-fixed in the prescribed 1 : 1 ratio as detailed in the Annexure-II appended herewith. All District Medical Officers are directed to take necessary action to maintain the staff strength in their concerned districts as detailed in Annexure-II here after. The District Medical Officers shall report the arising vacancies of Lab Technician Gr.II to PSC after setting apart the vacancies for inter district transfer/compassionate employment etc. and such Gr.II vacancies will be filled accordingly. The vacancies arising in the cadre of Lab Technician Gr.I should be reported to this office and posting in such vacancies will be made from this office by promotion/transfer. The institution wise transfer and posting of Lab Technician Gr.II and Gr.I within the district will be carried out by the concerned District Medical Officers in accordance with the statutory provisions in force. The above mentioned stipulations regarding transfer and posting of Lab Technician Gr.II and Gr.I shall not be violated under any circumstances.

The present strength fixation has been done taking into account the total number of Lab Technician posts existing as on 01/05/2020. Disparity in the present actual strength of Lab Technician Gr.II and Gr.I if in any districts will be re-arranged in future transfer/promotion as per the provisions laid down in Government 3<sup>rd</sup> and 4<sup>th</sup> read above.
