A finalised seniority list for by transfer appointment / promotion to the post of Junior Health Inspector Gr.II from among the feeder categories was prepared and published vide the order read as 4<sup>th</sup> paper above.


But several appeals has been received in this regard. After the scrutiny of the appeals, it is found that some appeals are genuine. As Such it is decided to review the seniority list. A hearing was also conducted in this regard.

In the above circumstances the seniority is reviewed on the basis of the following conditions.

1. The employees who are in government service as on 08-07-2008 and are working in Health Service Department as on 31-12-2010, possessing the qualification of Sanitary Inspector Course before 28-09-2010 are exempted from acquiring qualification of Diploma in Health Inspector Course. ( vide G.O.(MS) No. 23/2011 H & FWD, dated 20-01-2011

2. The employees working in the post of L.D.Clerk, Pharmacist, Typist, Driver, Dhoby, Barber, Cook and Tailor are excluded from the list of feeder categories for appointment of Junior Health Inspector Gr.II.( Vide G.O.(P) No.344/2008, H&FWD, Dated 08-07-2008
3. The departmental hands who had undergone the course without sanctioning Eligible Leave / Leave Without Allowance by the Superior Authority and without obtaining N.O.C. are excluded from the list
4. The seniority of the employees is assigned according to the date of acquisition of qualification, Date of joining in service and completion of probation period in the feeder category post in Health Service Department.

The revised seniority list for by transfer appointment / promotion to the post of Junior Health Inspector Gr.II from among the feeder categories as on 08-07-2008 is published herewith as annexure to this order.
