The Final Seniority list of Staff Nurses Gr.II for the period from 1.1.78 to 6.7.90 has been revised vide this office order as 1<sup>st</sup> above.

The Seniority list of Staff Nurses Gr.II for the period from 7.7.90 to 31.12.02 is prepared based on the details provided by the concerned District Medical Officer Health and according to the date of effective advice of the Kerala Public Service Commission. The following rules and regulations are also taken into account while preparing the list:

1. The DRB candidates who are appointed through more than one PSC will have their seniority with effect from the date of Advice of last PSC recruitment.
2. The Staff Nurses Gr.II recruited through the District Recruitment Board of the PSC will entail loss of seniority while securing inter-district transfer to district other than their district of appointment.
3. The inter-departmental candidates will have their seniority with effect from the date of joining this department.
4. The Staff Nurses GrII who have availed Leave without Allowances under Appendix XIA, XIIB & XIIC before the declaration of probation will have their seniority assigned with effect from the date of rejoining duty after LWA.
5. The Staff Nurses GrII who have availed extension of joining time for more than three months from the date of order of appointment will have their seniority assigned with effect from the date of joining.

A preliminary seniority list of Staff Nurses Gr.II is prepared and circulated to all through the concerned District Medical Officer of Health vide this office order read as 2<sup>nd</sup> above. All the appeals received from the Staff Nurses, on the preliminary list were considered on merit taking into account the rules and regulations mentioned above and are given appropriate place in the final list.

The final seniority list of Staff Nurses for the period from 7.7.90 to 31.12.2002 is thus prepared and appended to this order. The Staff Nurses Gr.II in this list who is appointed by the District Recruitment Board will entail loss of seniority if they secure inter-district transfer to districts other than their district of appointment, before their next promotion.

The District Medical Officer is requested to circulate the list to all concerned in their district.
