

## **Proceedings of the Director of Health Services, Thiruvananthapuram**

Sub:- Estt:HSD–Revision of Seniority List of JHI Gr. II for the period 1/1/1997 to 31/3/2000 in compliance of the judgement of Hon'ble High Court in OP (KAT) 31,32 & 135/2015–Final Seniority List publishing of– orders issued.

### **Order No. ES1-14462/2015/DHS dtd. 8/11/2018.**

In compliance of the order in Judgement in WP (C) No. 10496/04 dtd. 23/3/2004 a combined gradation list of Junior Health Inspector Gr. II was published on 5/1/2008 vide order read as 1<sup>st</sup> above in which the persons possessing first preferential qualification (ie. HIC) were ranked as list I and the others were ranked as List II. That was challenged in various OPs.

In compliance of the judgement dtd. 30/6/2010 in WP(C) 14886/2005 WP(C) 15535/2005 and GO (Rt) No. 893/10 H&FWD dtd. 4/3/2011 the list was revised and published a combined seniority list as per the order read as 2<sup>nd</sup> above according to the provision under Rule 27(c) part II KS&SSR by taking advice in case of all PSC direct recruits and the latter date of occurrence of vacancy and qualified seniority in case of persons appointed by transfer. That seniority list was challenged in OP (KAT) 31, 32 & 135/2015 and the final judgement of Hon'ble High Court was issued on 2/3/2018. The operative part of the Judgement is that the seniority granted to the persons having first preferential qualification by virtue of judgement dtd. 24/11/2004 is WA No. 2848/2000 cannot be nullified and at the same time, the Hon'ble High Court have directed to fix the seniority of persons belonging to the petitioners in WP(C) No. 15535/2000 (ie. The persons having non preferential qualification) according to the direction in Judgement dtd. 30/6/2010.

Some incumbents included in the seniority list of Junior Health Inspector Gr. II who are possessing SIC qualification filed SLP 12363/2018 before the Hon'ble Supreme Court against the Judgement of Hon'ble High Court dtd. 2/3/2018. The Hon'ble Supreme Court has pronounced an interim order dtd. 27/7/2018 vide read as 5<sup>th</sup> above, "Any promotion shall be subject to the outcome of the appeal".

Sri. Johnson George, Junior Health Inspector Grade I and three others were filed OA (EKM) No. 929/2018 before the Hon'ble Kerala Administrative Tribunal and the Hon'ble Tribunal have disposed of the OA as per the order dated 11/4/18 read as 4<sup>th</sup> above by directing the first respondent ie, the Government to consider and pass appropriate orders after hearing the applicants and all the other affected parties. Government have issued an order dtd 12/9/2018 vide read as 6<sup>th</sup> above after hearing the applicants and affected parties. As per that GO(Rt) No. 2797/2018/H&FWD dtd 12/9/18 Government have directed to effect provisional promotion from the List I of the order dtd. 5/1/2008 at once against the existing vacancies of Health Inspector Gr II. It should be mentioned outcome of SLP No. 12363/2018 and OA 620/2018. There after the seniority of the incumbents included in the list II in the order dtd. 5/1/2008 should be reassigned by rectifying the defects if any, considering the date of advice in the case of direct recruitment by Public Service Commission and the date of order of appointment in the case of by transfer appointment and other rules in force and a modified seniority list should be issued subsequent to the above process within one month from the date of receipt of the order.

As instructed by the Government Order read as 6<sup>th</sup> above, a provisional seniority list of Junior Health Inspector Gr. II (List II) for the period from 1/1/1997 to 31/3/2000 had been revised and published as per order read as 7<sup>th</sup> above. Final seniority list of JHI Gr. II for the period from 1/1/1997 to 31/3/2000 is published herewith after considering the appeals received within the stipulated time, subject to the outcome of SLP No. 12363/18 and OA No. 620/18. The judgement dtd 2/3/2018 of Hon'ble High Court in OP (KAT) 31, 32 & 135/2015 and the order dtd. 11/4/2018 of Hon'ble Kerala Administrative Tribunal in OA (EKM) No. 929/2018 is complied accordingly.
