Sub:- Estt. – HSD – Transfer and Posting of Staff Nurse Gr.I and promotion of Staff Nurse Gr.II to the cadre of Staff Nurse Gr.I Sanctioned - Orders issued.

The following Staff Nurse Grade I are transferred and posted to the station noted against their names at their request as detailed in the annexure A.

As per order read 1st cited, the state/district wise strength fixation between Staff Nurse Gr.II and Staff Nurse Gr.I in the prescribed ratio was ordered considering the number of posts existed as on 31/12/2017. Accordingly, in view of the existing actual strength in both cadres, promotions can be made to the cadre of Staff Nurse Gr.I considering the present disparity between the posts of Staff Nurse Gr.II and Gr.I with respect to the fixed strength.

In the above circumstances, the following staff Nurse Gr.II who were left out from earlier promotions due to various reasons and those who were on leave during the period of promotion and rejoined subsequently are promoted to the cadre of Staff Nurse Grade I in the scale of pay Rs.29200-62400 and allotted to the districts mentioned against their names as detailed in the list appended a Annexure B. Further, in continuation of order read 2nd the following Staff Nurse Gr.II between the rank number 2801 to 3500 in the seniority list of Staff Nurse Grade II for the period from 01/01/2003 to 30/06/2010 and whose whereabouts have been obtained from District Medical Officers are promoted to the cadre of Staff Nurse Gr.I in the scale of pay of

Rs.29200-62400 and allotted to the districts mentioned against their names as detailed in Annexure C.

All the incumbents who have been promoted has been retained in the present districts except those who have applied for interdistrict transfer consequent on promotion. Accordingly, the total strength of Staff Nurse Gr.I in Ernakulam and Thrissur districts have exceeded the fixed strength resultant to promotion. They are temporarily retained in their present districts on administrative convenience and the junior most promotees shall be reallotted to other districts as and when required in accordance with the provisions specified in Government Order read 3rd. The transfer request of those promotees to Ernakulam and Thrissur districts have not been considered, since the total strength of Staff Nurse Gr.I in those districts have exceeded the fixed strength consequent on promotion.

The District Medical Officers of Health concerned will issue necessary posting orders to those incumbents who have been newly transferred to their districts. The incumbents who have been promoted and retained in the present district shall be allowed to continue in their present stations subject to review during General Transfer 2018 if required.

Before permitting the promotees to join duty in the promoted post, the District Medical Officer of Health concerned/head of institution should confirm their rank number, name and date of birth. If any employee is promoted due to faulty whereabouts and who are not in service (LWA, Suspension) their name should be reported to this office by the District Medical Officer concerned.

The following employees are exempted from the promotion order

- 1. Those staff nurses who opted to Medical Education Department.
- 2. Those employees whose whereabouts are not known.
- 3. Those employees whose names are included in the seniority list, but availed IDT or LWA before effecting promotion.

If any discrepancy in this order is noted, it should be reported to this office within 15 days through proper channel. In the case of incumbents who are in service at present and who are left out from the above promotion due to want of whereabouts, they shall submit appeals through proper channel within 15 days from the date of this order with supporting documents. The promoted incumbents who have not availed the benefit of 1st Time Bound Higher Grade will be eligible for fixation of pay order Rule 28 A Part I, KSR accordance with the provision specified in order read 4th. Necessary entries should be recorded in the Service Book of the concerned incumbents and office records in this regard with proper attestation.

All District Medical Officers of Health/head of institutions/ promoted employees are authorised to use the printout of this order published in the official website of the Directorate of Health Services for official purpose.
