The candidate whose particulars are furnished below and who have been advised by the Kerala Public Service Commission as per the letter read above for appointment to the post of Junior Consultant (General Surgery) is temporarily appointed in the Health Services Department in the scale of pay of Rs.63700-123700, under clause(1) sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10 (b) of those Rules (vide G.O.(P) No.49/74/PD dated 05.03.1974) and posted to the institutions noted against his/her name, subject to the condition that his/her appointment shall be terminated without further notice if the appointing authority is not satisfied with his/her conduct and antecedents on subsequent verification. They shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification and guidelines issued as per GO (P) No.41/2010/PA&RD dated 14.12.2010. The appointment is also subject to Rule 3.(C) of General Rules of Kerala State and subordinate Service Rules 1958.

The candidate is directed to report for duty before the District Medical Officer of Health concerned on or before 11.10.2021 and he/ she is actually permitted to join duty in the respective institution to which the candidate is posted.
