Read: Advice No R1 E(3) 12257/13/GW Dated 18.03.2021 from the Secretary, Kerala Public Service Commission, Thiruvananthapuram.

**ORDER NO. EA3- 21590/2021/ DHS DATED: 28.04.2021**

The candidates whose particulars are furnished as per Annexure and who have been advised by the Kerala Public Service Commission as per their letter read above for appointment to the post of Assistant Surgeon/ Casualty Medical Officer is temporarily appointed in the Health Services Department in the scale of pay of Rs.45800-89000, under clause(1) sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10 (b) of those Rules (vide G.O.(P) No.49/74/PD dated 05.03.1974) and posted to the institutions noted against his/her name, subject to the condition that his/her appointment shall be terminated without further notice if the appointing authority is not satisfied with his/her conduct and antecedents on subsequent verification. They shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3 (C) of General Rules of Kerala State and subordinate Service Rules 1958.

The candidates are directed to report for duty before the District Medical Officer of Health concerned **on or before 12.05.2021** on publishing of the posting order and they are actually permitted to join duty in the respective institution to which the candidates are posted. The candidates should produce the original certificates ie Educational Qualification, Registration, Non Creamy layer, Fitness etc and ID proof for verification before the District Medical Officer of Health concerned. The District Medical Officer of Health should verify the above documents before permitting the candidates to join duty.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.
