1. Her appointment to the post of Assistant Surgeon will be in the scale of pay of Rs.45800 - 89000 and under Rule 9 (a)(i) of Kerala State and Subordinate Service Rules 1958.
2. Her appointment will be subject to the condition that the same shall be terminated without further notice if the Appointing Authority is not satisfied with her conduct and antecedents on subsequent verification.
3. She shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment will also be subject to Rule 3 (C) of General Rules and Subordinate Service Rules 1958.
4. She is bound to work in rural areas as and when posted.
5. She shall report for duty before the concerned District Medical Officers with all relevant records in original to prove their Qualification, Date of Birth, Certificate of Registration with Travancore - Cochin Medical Council. Medical Certificate of Physical Fitness of good health obtained from a Medical Officer not below the rank of Civil Surgeon in

Government Service (as per G.O.(P) No.20/2011/P&ARD dated, 30/06/2011). Those who are in reservation quota shall produce the original Community Certificate and Non-Creamy Layer Certificate.

6. The application for correction of date of birth, if any, required should be made by the candidates within five years from the date of entry in service.
7. The candidate shall join duty within seven days from the date of this order or on completion of extension period whichever is applicable failing on which her appointment will be cancelled and the vacancy will be reported to PSC as Not Joining Duty.
