ORDER NO. EA1-9094/2021/DHS dated: 24/06/2021

As per order read 1st, placement of Assistant Surgeons in this Department to various specialties in Specialty cadre was made and thereby Dr. Anoop G.C, who was working as Assistant Surgeon at Family Health Centre, Anakudy, Thiruvananthapuram was placed on the specialty of Orthopaedic Surgery and was posted to General Hospital, Pala, Kottayam. Since the order was issued in the midst of General Transfer 2020 and before finalization of General Transfer proceedings, it was specified in the order that the postings made will be reviewed in General Transfer 2020, if required. The final orders of General Transfer 2020 of Junior Consultants was issued vide order read 2nd and accordingly, Dr. Arun Ravi, Junior Consultant(Orthopaedic Surgery) who was working at Taluk Head Quarters Hospital, Kanjirapally, Kottayam was transferred and posted to General Hospital, Pala, Kottayam being the eligible incumbent for transfer to the institution as per norms by replacing Dr.Anoop.G.Cand he was posted to General Hospital, Irinjalakkuda, Thrissur on administrative grounds vide order read 3rd. Dr. Anoop.G.C had then filed OA 275/2021 challenging his transfer and praying for retention at General Hospital, Pala upon which the Hon. Tribunal issued order read 4th staying the transfer of Dr. Anoop. G.C to General Hospital, Irinjalakkuda. Since Dr. Arun Ravi was already relieved from General Hospital, Kanjirapally consequent on joining of substitute and his transfer to General Hospital, Pala could not be effected due to stay imposed on transfer of Dr. Anoop. G.C., Dr. Arun Ravi was reposted to General Hospital, Irinjalakkuda on Administrative grounds vide order read 5th ,pending disposal of OA 275/2021. Subsequently, Dr.Arun Ravi filed OA 393/2021 challenging order read 5th

upon which, the Hon.Tribunal have now issued common order read 6^{th} , in OA 275/2021 & OA 393/2021.

The Hon.Tribunal, in order read 6th, have observed that it is unable to accept the contention of Dr.Anoop.G.C, applicant in OA 275/2021 that he is entitled to continue at General Hospital Pala for three years as per transfer guidelines and also that he has not been able to substantiate his contentions. The Hon.Tribunal have dismissed OA 275/2021 by setting aside order read 5th and allowing OA 393/2021 with direction to Director of Health Services to issue required consequential orders within one month of receipt of copy of order.

In the above circumstances, the following transfer of the above said officers are made with immediate effect.
