1. Original documents to prove the date of birth and Educational Qualification etc.
2. Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. The candidate should affix recent passport size photograph duly attested by the issuing officer.
3. Prescribed community certificate.
