The candidates appointed shall come under the new pension scheme. The candidates should produce the following documents at the time of joining duty.

1. Original documents to prove the date of birth and Educational Qualification etc
2. Certificate of Physical Fitness obtained from Medical Office in Government Service not below the rank of Civil Surgeon/Consultant. The candidates should affix recent passport size photograph duly attested by the issuing officer.
3. Prescribed community certificate.

The appointment order in this proceedings is purely temporary and the candidates are eligible for appointment in regular service only if themselves character and antecedents are found satisfactory on subsequent verification.

In the event of discharge from service for want of vacancies, the candidates may either register their names in the office of the Public Service Commission from where they were advised and get themselves re-appointed on further advice by the Public Service Commission or they may wait for their turn for re-appointment to the post in the department in case they desire to continue as probationer in the posts from which they were discharged vide Government Circular Memorandum No.3737 Rule 1/90 P&ARD dated, 15/02/1991. The appointment is also subject to Rule 3(c) 7 General Rules of Kerala State and Subordinates Service Rules 1958.

Application for correction of date of birth if any needed should be made by the candidates within five years from the date of entry in service.
