**ORDER NO:EA2-50483/2014/DHS. Dated: 26.12.2014**

As per this office order cited 1<sup>st</sup>, the final seniority list of Medical Officers for admission to Post Graduate courses 2014 under Health Service Quota was published. The incumbents secured admission to the respective courses as per merit through counselling conducted by Commissioner for Entrance Examinations. But as per the judgment of Hon: High Court of Kerala read 2<sup>nd</sup>, the seniority list was revised and as a result the names of certain Medical Officers who had been already admitted to PG Course were deleted from the seniority list. Consequently, their admission through Health Service Quota got cancelled. They were relieved from the concerned Medical Colleges upon cancellation of admission and had to be reposted. Hence they were reposted vide the order read 3<sup>rd</sup>.

Now the following Asst. Surgeons have requested to regularise the intervening periods between the relieving and rejoining time, with relevant RTCs.
