ORDER NO. EA2- 20627/2023/DHS Dated: 28-10-2023

Dr.Chitra S (PEN.715483), Assistant Surgeon, Primary Health Centre Vamanapuram, Thiruvananthapuram was transferred and posted to General Hospital Adoor, Pathanamthitta in General Transfer 2023. Against this she filed OA 1024/2023 before the Honourable Kerala Administrative Tribunal. In accordance with the direction in that O.A, Government as per GO(RT) No. 2655/2023/H&FWD Dated 12.10.2023 issued compliance order directing the Director of Health Services to consider Dr.Chitra S in the existing vacancy at Primary Health Centre Uzhamalakkal Thiruvananthapuram based on merit.

2. Dr.Chitra. S filed another OA No.1866/2023 before Kerala Administrative Tribunal. The Hon'ble Kerala Administrative Tribunal in the Order read above directed the 2nd Respondent (Director of Health Services) to accommodate the applicant provisionally against the open vacancy at Uzhamalaikkal. The Hon'ble Tribunal made it clear that as and when the 1st respondent (Government) passes orders on all the appeals, her case can be considered along with others on merit.

3. In the above circumstances, Dr. Chithra S, Assistant Surgeon, Primary Health Centre Vamanapuram, Thiruvananthapuram is hereby **provisionally** transferred and posted at Primary Health Centre Uzhamalakkal in the existing vacancy. This provisional transfer will be reviewed later as and when the
