ORDER NO. EA2- 503/2023/DHS Dated 27-02-2023

As per a provision in Special Rule 2010, there were not enough qualified officers in Junior Administrative Medical Officer cadre and promotion in the cadre of Assistant Director has not been done since 15.02.2019. Due to this situation several vacancies occurred in Assistant Director posts. For the smooth functioning of various institutions under Health Services Department, Government have issued several orders for filling the vacancies of Assistant Director posts as Junior Administrative Medical Officers. As per references 1st to 11 cited, 44 Assistant Director posts were temporarily downgraded as Junior Administrative Medical Officer posts. Now Government have upgraded these posts as Assistant Director as read 12th above. As read 13th, Junior

Administrative Medical Officers are promoted as Assistant Director and posted to various institutions mentioned in 12th and open vacancies.

In these circumstances, the following Junior Administrative Medical Officers those who are now working on that upgraded posts are transferred and posted to the stations noted their names.
