**ORDER**

As per the General Transfer Order 2021 of Civil Surgeons, issued as per G.O read as 1st paper above, Dr.Babu.U., Civil Surgeon, Taluk Head Quarters Hospital Kondotty was transferred to Community Health Center, Pazhanji, Thrissur District. Against this transfer order, the applicant filed OA766/2022 before the Hon'ble Kerala Administrative Tribunal and in compliance with the order dated 31-05-2022 of Hon'ble Kerala Administrative Tribunal in OA766/2022, the G.O. read as 2nd paper above was issued. In this order, Director of Health Services was directed to consider the applicant for posting to the vacancy of Civil Surgeon in MCH Unit, Cheroopa, Kozhikode, if such vacancy is existing as pointed out by the applicant or to any subsequent vacancy arising due to retirement or promotion etc. which may be convenient to the applicant after considering eligibility of other claimants if any, with

respect to those vacancies.

2. But the application of Dr.Babu.U was not considered while filling the vacancy at Cherooppa. Against this, he filed OA (EKM) 1501/2022 before the Hon'ble Kerala Administrative Tribunal and as per the order read as 3rd paper above, the Hon'ble Tribunal directed the second respondent, ie., the Director of Health Services, to consider the applicant for transfer as and when vacancy arises at MCH Unit Cherooppa or Taluk Head Quarters Hospital Kondotty in view of the direction contained in the order read as 2nd paper above, by issuing necessary orders at any rate before filling up those vacancies. Accordingly, the Director of Health Services, as per the letter read as 4th paper above, proposed to transfer Dr.Babu.U to Taluk Hospital ,Kondotty ,Malappuram in the existing vacancy.

3. Government have examined the matter in detail and are pleased to transfer Dr.Babu.U, Civil Surgeon, Community Health Centre ,Pazhanji,Thrissur to Taluk Headquarters Hospital ,Kondotty, Malappuram in the existing vacancy.

4. The Order dated 09/11/2022 of the Hon'ble Kerala Administrative Tribunal in OA (EKM) 1501/2022 is thus complied with.
