- 2. Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. The candidate should affix recent passport size photograph duly attested by the issuing officer.
- 3. Prescribed community certificate.
- 4. Should produce a certificate to prove his lien in the department from which he has obtained service certificate while applying for the post or a certificate

- starting that he has not got confirmation for the post in which he is working presently.
- 5. The Advice and appointment for the post will be subject to further orders in the OA No. (EKM) 1598/2022 communicated vide letter No. AIV (1) 41/2022-KPSC, dated: 26/11/2022 of the Secretary, KPSC, Thiruvananthapuram.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if his character and antecedents are found satisfactory on subsequent verification.

In the event of discharge from service for want of vacancies, the candidate may either register his name in the office of the Public Service Commission from where he was advised and get himself re-appointed on further advice by the Public Service Commission or he may wait for his turn for re-appointment to the post in the department in case he desire to continue as probationer in the posts from which he was discharged vide Government Circular Memorandum No.3737 Rule 1/90 P&ARD dated, 15/02/1991.
