2.) Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. The candidate should affix recent passport size photograph duly attested by the issuing officer.
3.) Prescribed community certificate.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if his character and antecedents are found satisfactory on subsequent verification.
