1. Original documents to prove the date of birth and education qualification etc.
2. Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Assistant Surgeon. The candidate should affix recent passport size photograph duly attested by the issuing officer.
3. Those who are in reservation quota shall produce the original Community Certificate and Non-Creamy Layer Certificate.
4. Candidates who have applied for by transfer appointment ,should produce a certificate before the appointing authority to prove his lien from the department in which she his obtained service certificate while applying for the post or a certificate stating that she his not got confirmation for the post he is working presently.
5. The Advice and appointment for the post will be subject to final orders in the OA No. (EKM) 1598/2022 communicated vide letter No. MR I-1/1/2021-11 Dated:22/01/2024, KPSC Malappuram.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if his character and antecedents are found satisfactory on subsequent verification.

In the event of discharge from service for want of vacancies, the candidate may either register his name in the office of the Public Service Commission from where he was advised and get himself re-appointed on further advice by the
