2. Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon/Consultant. The candidate should affix recent passport size photograph duly attested by the issuing officer.
3. Prescribed community certificate.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if her character and antecedents are found satisfactory on subsequent verification.

In the event of discharge from service for want of vacancies, the candidate may either register his name in the office of the Public Service Commission from where she was advised and get himself re-appointed on further advice by the Public Service Commission or he may wait for his turn for re-appointment to the post in the department in case he desire to continue as probationer in the posts from which he was discharged vide
