**ORDER NO EA2 : 151/2023 /DHS DATED : 20-11-2023**

Dr.Rejani V R (PEN 787583), Assistant Surgeon was worked at Primary Health Centre Mararikulam North Alappuzha since 16.11.2016. While considering the options of other eligible incumbents, Dr. Rejani V R has been posted at Taluk Hospital, Varakala in General Transfer 2023. Against this she filed OA 1053/2023 before the Honourable Kerala Administrative Tribunal. In accordance with the direction in that O.A, Government issued compliance order as per read 2nd above by directing to consider Dr.Rejani V R in the vacancy of her options in General Transfer 2023. As per read 3rd above Dr.Rejani V R has submitted a request for considering her in the vacancy exists at Community Health Centre, Vilappil (Which was one of her options in General Transfer 2023).

2. In the Order read as 1st paper above, the Hon'ble Tribunal has directed the Director of Health Services to consider the case of the applicant (Dr Kaveri Varma, Assistant Surgeon) based on the comparative merit along with the other claimants in tune with the directions in the Annexure A. 14 Order while filling up the vacancy at Community Health Centre, Vilappil.

3. In compliance of the order of Hon'ble Kerala Administrative Tribunal read 1st above this office has verified merits of Dr,Rejani V R and Dr.Kaveri Varma for transfer to the post at at Community Health Centre, Vilappil. Dr.Kaveri Varma worked at Thrivanathapuram District from 16.09.2010 on wards and she did not submit online application in General Transfer 2023. It is seen that while considering the health condition and outstation seniority of Dr.Rejani V R, Dr.Rejani V R is more eligible person to be posted at Community Health Centre Vilappil. Hence Dr,Rejani V R, Assistant Surgeon, Taluk Hospital Varkala is hereby transferred and posted to Community Health Centre, Vilappil in the existing open vacancy.

4. Thus the order of Hon'ble Kerala Administrative Tribunal read 1st above is complied with accordingly.

5. The incumbents and Head of the Institution are authorized to take print out this order from the official website of the Director of Health Services for official use.
