**ORDER NO EA2 : 151/2023 /DHS DATED : 20-11-2023**

In the General Transfer 2023, Dr Viya R Vijayan (PEN.701654) Assistant Surgeon, Community Health Centre Perinkadavila,Thiruvananthapuram was transferred and posted to Community Health Centre Chittar, Pathanamthitta.. Against this she filed OA 986/2023 before Honourable Kerala Administrative Tribunal. In accordance with the direction in that O.A, Government as per read 3rd above issued compliance order and directed to consider Dr.Vidhya R Vijayan in the vacancy at her options based on merit.

2.Similarly,Dr.Chitra S (PEN.715483), Assistant Surgeon, Primary Health Centre Vamanapuram, Thiruvananthapuram was transferred and posted to General Hospital Adoor, Pathanamthitta in General Transfer 2023. Against this she filed OA 1024/2023 before the Honourable Kerala Administrative Tribunal. In accordance with the direction in that O.A, Government as per read 2nd above issued compliance order directing the Director of Health Services to consider Dr.Chitra S in the existing vacancy at Primary Health Centre Uzhamalakkal Thiruvananthapuram based on merit.

3.Dr. Chitra. S filed another OA No.1866/2023 before Kerala Administrative Tribunal. The Hon'ble Kerala Administrative Tribunal in the Order read above directed the 2nd Respondent ( Director of Health Services) to accommodate the applicant provisionally against the open vacancy at Uzhamalaikkal. The Hon'ble Tribunal made it clear that as and when the 1st respondent (Government) passes orders on all the appeals, her case can be considered along with others on merit.By obeying the order of Hon'ble Kerala Administrative Tribunal this Office has provisionally transferred and posted Dr.Chitra S at Primary Health Centre Uzhamalakkal in the existing vacancy as per read 4th above.

4 As per read 5th above Dr.Vidya R Vijayan has requested to post her in the

existing vacancy available at Primary Health Centre Uzhamalakkal on compassionate ground.

5. Now Government have issued orders disposing appeals filed against the general transfer 2023 on the basis of the recommendation of the Appeal Committee constituted in Government.

6. In this circumstances this office has examined the merit of Dr.Vidya R Vijayan and Dr. Chitra. S for the vacancy at Primary Health Centre Uzhamalakkal. Considering the health condition of Dr.Vidya R Vijayan, she is to be posted in the vacancy at Primary Health Centre Uzhamalakkal. Hence provisional posting of Dr.Chitra S given in the Primary Health Centre Uzhamalakkalas per Proceedings read as 4th above is hereby reviewed and Dr.Vidya R Vijayan Assistant Surgeon, Community Health Centre, Chittar,Pathanamthitta is hereby transferred and posted to Primary Health Centre Uzhamalakkal vice Chitra S is transferred. On transfer Dr.Chitra S is posted to Taluk Head Quarters Hospital, Parassala as Casualty Medical Officer in the existing open vacancy .
