ORDER

Dr. Sreekumar Mukundan filed OA(EKM) No. 1883/2023 aggrieved by his transfer from General Hospital, Kalpetta, Wayanad to General Hospital, Kasargod as per GO read as 1st paper above. The Hon'ble Tribunal as per the Order read as 3rd paper above has directed the 1st respondent ie., Principal Secretary, Health & Family Welfare Department to consider and pass orders on Annexure A10 within a period of one month from the date of receipt of copy of the order after hearing the applicant and any other stake holders. In the Annexure A10 ie., appeal read as 2nd paper above, the applicant has requested to cancel the order of Dr. Shaj M.K., who was posted as Superintendent, District Hospital, Kannur and to post him in that place. It was also requested to cancel the posting of Dr. Moideen Shah to Kalpetta, Wayanad and to retain him at General Hospital, Kalpetta. The applicant has requested either to transfer him to Thalassery/Kannur or to retain him in the present station.

2. As per the Order of the Hon,ble Tribunal, Dr. Sreekumar Mukundan was heard at the Government level on 18.1.2024. Dr. Moideen Shah P. M, Dr. Shaj.M.K & the officials from the office of the Director of Health Services were present. The Applicant, Dr. Sreekumar Mukundan contented that he requested for a transfer to Kannur District as requested earlier and if not possible, consider him to Kannur District in the General Transfer for the next year and allow him to continue in General Hospital, Kalpetta. Dr. Moideen Shah P. M has preferred to post him as DMO, Wayanad, and Dr. Shaj.M.K preferred to be retained in District Hospital, Kannur.

3. The Director of Health Services has informed that Dr. Sreekumar Mukundan, Deputy Director has been working at General Hospital, Kalpetta from 7.8.2019. He had opted General Hospital, Thalasserry and District Hospital, Kannur during General Transfer 2023, but no vacancy was available at his opted places as per the General Transfer norms issued by the Government. After the General Transfer, transfer and postings in District Hospital, Kannur and General Hospital, Kalpetta have been effected purely based on administrative convenience, for the smooth functioning of the respective institutions and are in order and hence the appeal preferred by the applicant is liable to be rejected.

4. Government have examined the matter in detail. Considering the facts and circumstances of the case, the Annexure A10 appeal preferred by Dr. Sreekumar Mukundan, is not allowable and hence is declined. The Order of the Kerala Administrative Tribunal read as 2nd paper above is complied with accordingly.
