**ORDER NO. EA3- 2214/2023/DHS DATED: 21.02.2023**

The candidates whose particulars are furnished as per Annexure and who have been advised by the Kerala Public Service Commission as per their letter read above for appointment to the post of Assistant Surgeon is temporarily appointed in the Health Services Department in the scale of pay of Rs. 63700-123700, under clause (1) sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10 (b) of those Rules (vide G.O.(P) No.49/74/PD dated 05.03.1974) and posted to the institutions noted against his/her name, subject to the condition that his/her appointment shall be terminated without further notice if the appointing authority is not satisfied with his/her conduct and antecedents on subsequent verification. They shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3 (C) of General Rules of Kerala State and subordinate Service Rules 1958.

The candidates are directed to report for duty before the District Medical Officer of Health concerned on or before **27.02.2022** and they are actually permitted to join duty in the respective institution to which the candidates are posted. All the documents of Sl. No.1 should verify the concerned District Medical Officer of Health. Verification of remaining candidates are already done from this end.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service. In the case of those candidates who fail to join duty within stipulated time, their appointment will be cancelled and the vacancy will be reported to Kerala Public Service Commission as 'Not Joining Duty.'

This posting will be reviewed during General Transfer 2023, if it is required.
