The following candidate advised by Kerala Public Service Commission for appointment to the post of Assistant Surgeon in this Department vide advice read 1st and applied for extension of joining time. As per the order read 2nd Government ordered that the extension of joining time which exceeds 06 months will not allowed and the candidates who require extension beyond 06 months can avail Leave Without Allowance after joining service. Accordingly the following candidates included in the list appended are appointed as Assistant Surgeon/ Casualty Medical Officer in this department subject to the conditions specified below.

1. His/her appointment to the post of Assistant Surgeon will be in the scale of pay of Rs. 63700-123700 and under Rule 9(a)(i) of Kerala State and Subordinate Service Rules 1958.
2. His/her appointment will be subject to the condition that the same shall be terminated without further notice if the appointing Authority is not satisfied with his conduct and antecedents on subsequent verification.
3. He/she shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment will also be subject to Rule 3(C) of General Rules and Subordinate Service Rules 1958.
4. He/she is bound to work in rural areas as and when posted.
5. He/she shall report for duty before the concerned District Medical Officers with all relevant records in original to prove their Qualification, Date of Birth, Certificate of Registration with Travancore-Cochin Medical Council, Medical Certificate of Physical Fitness of good health obtained from a Medical Officer not below the rank of Civil Surgeon in Government Service (as per G.O(P) No. 20/2011/P&ARD dated 30/06/2011). Those who are in reservation quota shall produce the original Community Certificate and Non-Creamy Layer Certificate.
6. The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.
7. The candidate shall join duty on or before **03.03.2023** failing on which his/her appointment will be cancelled and the vacancy will be reported to PSC as Not Joining Duty.
