ORDER

Dr.Manoj.G., while working as Senior Consultant General Medicine at General Hospital, Ernakulam was promoted to the cadre of Chief Consultant and posted at General Hospital, Pathanamthitta as per Government Order read as 1st paper above. The Medical Officer submitted a representation before the Principal Secretary that the Chief Consultant post in Specialty Cadre is floating in nature and that he had requested to consider rectification of his posting to General Hospital, Ernakulam instead of Pathanamthitta. He also filed OA (EKM) 362/2023 before the Hon'ble Tribunal praying the same request.

2. In the judgment read as 2nd paper above the Hon'ble Tribunal directed the applicant to produce his revised representation before the 1st respondent within a period of one week from the date of judgment and if such a representation is filed by the applicant, the 1st respondent was directed to consider the same

within a period of one month thereafter. It is also mentioned in the judgment that while passing orders on the representation filed by the applicant, the 1st respondent will also take note of Annexure A4 Medical Certificate and A7, Government Order by which Dr.Mohammed Ashraf.P.A. was provisionally promoted to the post of Chief Consultant and given posting at District Hospital, Nedumangad, Thiruvananthapuram. In his newly submitted application read as 3rd paper above, the applicant submits that since his health condition required intensive medication and care and since his request for posting at General Hospital, Ernakulam was rejected by the respondents, he may be accommodated in District Hospital, Aluva.

3. The Director of Health Services in the letter read as 4th paper above has reported that, considering the health condition of the Medical Officer, Dr.Manoj can be given posting at District Hospital, Aluva.

4. Government have examined the matter in detail. Since the Chief Consultant post is of floating in nature and also considering the health condition of the Medical Officer, Government are pleased to post Dr.Manoj.G, Chief Consultant in General Medicine at District Hospital, Aluva.

5. The judgement dated 31.03.2023 in OA (EKM) No.362/2023 filed by Dr.Manoj.G, Chief Consultant in General Medicine is complied with accordingly.
