As per read 3rd & 4th above Dr.Ashok Abraham Varghese and Dr.Aneesh Kumar G S submitted request for rejoining duty as Assistant surgeon after completing their Post Graduation Course.Since there were no vacancy of Assistant Surgeon existed at that time in this department,they couldn't join duty as Assistant Surgeon after completion of their PG Course.Then they were posted as Assistant Surgeons as per read 1st and 2nd above.Thereafter as per paper read 5th and 6th above this office has regularized the period waited for posting as duty. Now as per read 7th above Government have intimated that the period waited for posting cannot be treated as duty when there was no vacancy existed in the cadre.Government have directed to cancel the order in which the period waited for posting as duty and also directed to regularize the period as LWA/other eligible leave.

In the above circumstances the order read 5th and 6th above is hereby cancelled and the Medical Officers are directed to submit leave application for the purpose.
