ORDER

Director of Health Services as per letter read as 1st paper above furnished proposal for provisional promotion to the post of Consultant. Accordingly, as per Government Order read as 2nd paper above, Junior Consultants in various cadres were temporarily promoted to the post of Consultants. Thereupon the Director of Health Services as per letter read as 4th paper above has pointed out certain anomalies for rectification.

2. Government have examined the matter in detail and the following re-postings of Medical Officers are ordered with immediate effect to rectify the anomalies.

- i. Dr.Refik Anzar, Junior Consultant (psychiatry), District Hospital, Kottayam who stands promoted as Consultant and posted at District Hospital, Kozhencherry, Pathanamthitta is posted to Mental Health Centre, Thrissur in the newly created post as per Government Order read as 3rd paper above, since the post of District Hospital, Kozhencherry, Pathanamthitta has been shifted.
- ii. Dr.Manoj Kumar.K.P, Junior Consultant (PMR) who stands promoted as Consultant and posted at District Hospital, Kannur is posted at District Hospital, Palakkad since there is no vacancy at District Hospital, Kannur.
- iii. Dr.Sindhu.M, Junior Consultant (PMR), General Hospital, Alappuzha who stands promoted as Consultant and posted at General Hospital, Pathanamthitta is posted to District Hospital, Kottayam since there is no vacancy at Pathanamthitta.
- iv. Dr.Sughosh.K, Junior Consultant (ENT), General Hospital, Thalassery who stands promoted as Consultant and posted at District Hospital, Tirur is re-posted at Taluk Hospital, Payyannur, Kannur since there is no vacancy at District Hospital, Tirur.

3. The promotions effected to the following Medical Officers stands cancelled due to the reasons mentioned against their names :

Sl. No.	Name	Reasons to cancel promotions
1	Dr.Raveendran.S, Junior Consultant (General Medicine), District Hospital, Peroorkada, Thiruvananthapuram	Due to over sight occurred on the part of Director of Health Services the name of Dr.Raveendran.S has been entered mistakenly.
2	Dr.Lakshmi.R.Nair, Junior Consultant (Paediatrics), District Hospital, Neyyattinkara, Thiruvananthapuram	She is not working at District Hospital, Neyyattinkara. But she is on deputation at MLA Hostel Clinic, Thiruvananthapuram as Assistant Surgeon and cannot be promoted.
3	Dr.Mohan Kumar.V.K, Junior Consultant (ENT), General Hospital, Thalassery, Kannur	After returning from PG Course he has been posted as Junior Consultant (ENT) at Taluk Head Quarters Hospital, Aluva. In the counselling he had opted General Surgery and posted to General Hospital, Thalassery as Junior Consultant.
4	Dr.Usha, Junior Consultant (O&G), Taluk Head Quarters Hospital, Perumbavoor, Ernakulam	At present she is not in service. Her whereabouts is not known to Director of Health Services.

4. The Director of Health Services will furnish explanation for suggesting ineligible candidates for provisional promotion causing embarrassing situations of inappropriate Government Orders being issued and later being cancelled and wasting Government's time and man power. The Director of Health Services will also prepare updated incumbency register in respect of all categories and shall submit to Government an updated list of all categories where Government is the appointing authority.

5. The Director of Health Services shall also initiate disciplinary action against Dr.Usha for unauthorized absence if any.

6. The Director of Health Services shall furnish a compliance report within a month.

7. The Government Order read as 2nd paper above stands modified to the above extent.
