**ORDER**

Dr.Sivasankaran Paladan while working as Civil Surgeon at Primary Health Centre, Mankada, Malappuram was given placement as Consultant (Paediatrics) and posted at Taluk Head Quarters Hospital, Nilamboor as per G.O(MS)No.331/10/H&FWD dated 29.05.2010. But the Medical Officer did not join duty as he was on LWA for study purpose.

2. As per the Government Order read above he had been posted as Civil Surgeon at Community Health Centre, Narikkuni in Kozhikode district.

3. In the representation read above, the Medical Officer has requested pardon for not accepting the posting in time and requested to post him as Consultant in any of the vacancies at Kozhikode district under Speciality Cadre.

4. Government have examined the matter in detail and found that a mistake had occurred on the part of Government in issuing an order by posting him as Civil Surgeon (General Cadre) instead of giving placement in the speciality cadre.

5. Having examined the matter in detail, Government are pleased to post Dr.Sivasankaran Paladan as Consultant (Paediatrics) at Taluk Head Quarters Hospital, Payyannur, Kannur in the existing vacancy.
