only be considered)


**Method of Appointment**

i) By promotion from District Education and Media Officer/Health Education  
Extension Officer/Social Science Instructor/Social Scientist/Production & Distribution  
Assistant/School Health Education Officer/Technical Officer/CHEO/Dy.SMEMO.

**In their Absence**

ii) By promotion / transfer from any other category of post in the Health Services  
Department.

The circular should be communicated to all officials through the Head of Office/Institutions under your control without fail. The Head of Office/Institution concerned should verify the original certificates and other relevant records of the true copies of the certificates produced along with the application and forwarded later than 30-9-2013. The application which are received direct or late will not be entertained under any circumstances. The applications should be accompanied by attested true copies of all documents in proof of qualifications. The officer who attest true copies of the certificates will be held full responsible for any discrepancy if found later with the original certificates. The Head of Institutions will issue that the applications received are sent to this office so as to reach on or before 30.9.2013.
