

As per Government Order read as first paper above sanction was accorded for sponsoring 15 Government Employees for the Post Graduate Diploma in e-Governance. PGEeG is a joint programme, offered by Institute of Management in Government (IMG) and Indian Institute of Information Technology and Management- Kerala (IIITMK) for one year duration, with the objective of quality training in the area of e-Governance for successful implementation of e-Governance projects of government of Kerala. The course is spread across 2 semesters of one year duration with an intake of 45 participants. Out of 45 seats, 15 seats are reserved for Government Officials. The course fee is Rs. 75,000 which is shared in the rate 90:10 between Government and the deputed employee for the course.

All state employees who are Government employees and, have completed PGDeG course successfully. Programme for 4th batch is going on and will be completed by July 2013.

Sponsoring of 15 Government employees for the PGDeG course is intended to fulfill the capacity building i.e, to manage e-Governance projects implemented in the state. It envisages to develop a pool of human resources with Government who would be able to manage the IT Divisions of the respective departments.

As per the Government Order read as 2 above, the Government have strictly ordered that the service of these employees should be utilised in e-Governance

projects.

In this circumstances, for optimum utilization of the services of Government employees who completed the course for e-Governance initiatives in their departments following instructions are issued.

1. Head of Departments are requested to forward a list of nominated candidates with their resume, Non Objection Certificate and testimonials on or before 20-05-13 to Director, Kerala State IT Mission, ICT Campus, Vellayambalam, Thiruvananthapuram. Ph: 0471-2726881, 2314303. Fax: 2314284.
2. Department shall nominate 2 qualified officers for the year 2013-14.
3. While granting NoC, the department would also consent that the said employee would be deputed for one year for the purpose of the said course in case he is selected.
4. (a) Specify criteria for the selection of candidate.
(b) Role to be assigned/ project to be assigned/to the candidate on successful completion of the course.
5. An undertaking from the Head of Departments that service of employees who complete the course will be fully utilized in an effective manner for e-Governance projects of their departments/projects.
