

Proceedings of the Additional Director of Health Services (Medical), Directorate of Health Services, Thiruvananthapuram

Sub:- Estt-Health Services Department- Provisional Promotion of Pharmacist Grade-I to the cadre of Pharmacist Store Keeper- Orders Issued

ORDER NO. EE4- 50944/2015/DHS dated.19/08/2016.

Promotions to the cadre of Pharmacist Store Keepers are being effected from the seniority lists of Pharmacist Grade-II published from time to time. The seniority list of Pharmacist Gr-II for the period from 01/01/1978 to 14/12/1990 was published vide order read 1st. The seniority position of certain incumbents included in the said list was challenged in the Hon.High Court vide W.P(C) 16031/2010. As per the order of the Hon. High Court in the said petition, it was decided to revise the seniority list and modified list was published vide order read 2nd with Government permission. Thereafter, promotions to the cadre of Pharmacist Store Keepers were made from the revised seniority list as per order read 2nd.

The seniority position of certain incumbents included in the seniority list read 1st was downgraded due to modification. Some of the affected persons challenged the revision before the Hon. High Court/ Hon.Kerala Administrative Tribunal. Consequent on a series of legal procedures, the revision of seniority list referred 1st has been ultimately stayed as per interim order of the Hon. Kerala Administrative Tribunal on O.A 1271/2014 filed by Smt. Jaimol & Others. Accordingly, promotion to the cadre of Pharmacist Store Keeper and higher post of Store Superintendent was interrupted as the basic seniority list was on uncertainty.

Shri. Ajithkumar.K.C, Pharmacist Store Keeper filed O.A (EKM) 724/2014 before the Hon. Kerala Administrative Tribunal praying to effect promotions to the cadre of Store Superintendent. The Hon. Tribunal vide order read 3rd had observed that *promotions cannot wait for settling all seniority disputes and have to be ordered based*

on the seniority list holding in the field at the relevant time. Accordingly, the Hon Tribunal directed to effect promotions to the cadre of Store Superintendent from the seniority list of Pharmacist Store Keepers published, based on the pre-revised seniority list of Pharmacist Gr-II for the period from 1978-1990 as per order read 1st. The Hon. Tribunal also directed that if the seniority list is modified later, promotions made relying on it shall also be reviewed. Based on the order of the Hon. Tribunal, promotions to the cadre of Store Superintendent were effected after convening Departmental Promotion Committee.

The last promotion to the cadre of Pharmacist Store Keeper was made vide order read 4th and further promotions were not made due to the above mentioned seniority dispute. The stoppage of promotions for a long period has led to existence of large number of vacancies of Pharmacist Store Keepers. At present 76 posts out of total 110 sanctioned posts of Pharmacist Store Keepers are lying vacant and further vacancies are expected on promotion to the cadre of Store Superintendent. The situation of about 70% of posts lying vacant has adversely affected the functioning of Pharmacy Services in major hospitals. Most of the Pharmacy Stores are presently functioning under charge arrangements and this has led to administrative inconvenience. In order to tide over the situation, it was decided to find out alternate possibilities for effecting promotion to the cadre of Pharmacist Store Keepers without superseding any rules or contrary to any Court directions. Accordingly, it was further decided to adopt the same principle followed in promotion to the higher cadre of Store Superintendent in the case of Pharmacist Store Keeper also by assigning the order of the Hon. Kerala Administrative Tribunal read 3rd as the benchmark. Therefore it was concluded that since the revision of seniority list read 1st is under dispute and promotion to the higher cadre has already been effected based on the said list, promotions to the cadre of Pharmacist Store Keeper may be made provisionally from seniority list referred 1st considering the same as the one which is existing and the said promotions can be reviewed if necessary, based on the final verdict of the Hon. Kerala Administrative Tribunal on O.A 1271/2014.

In the above circumstances, the following Pharmacists presently working in the cadre of Pharmacist Grade-I and who are remaining to be promoted from the seniority list referred 1st and those who are included in the subsequent seniority list referred 5th, are provisionally promoted to the cadre of Pharmacist Store Keeper in the scale of pay of Rs.30700-65400 as per Rule 31(a) of KS&SSR and posted to the stations mentioned against their names as detailed in the list appended. **The promotions are made purely on provisional basis considering exigencies and will be reviewed if necessary based**

on the final order of the Hon. Kerala Administrative Tribunal on O.A 1271/2014.
The promotees will be placed on probation for a period of one year of duty within a continuous period of 2 years from the date of joining duty.

Any corrections/Omissions regarding this order should be brought to the notice of the undersigned within Seven days ie. on or before 26/08/2016. The date of relief and joining duty should be reported to this office promptly. The incumbents and other concerned officers are authorized to use the printout of this order published in the website of this Department for official purpose.
