The Final seniority list of L.D.Clerk during the periods 1986-1990, 1990-1993, 1994-1997, 1997-2002, 2003-2008 are published vide papers read as 1st to 5th above respectively.

The Final seniority list of senior clerks who are promoted as senior clerk during the period from 17/06/2000 to 31/12/2012 has been published vide order read as 6th above. Certain appeals have been received regarding assignment of seniority in the cadre of L.D.Clerk. On verification of the service particulars it was noticed that the rank number of 25 Incumbents, who were included in various seniority list of L.D.Clerk during the period from 1986 to 2008, are seen wrongly assigned and promoted to the cadre of U.D.Clerk on the basis of this wrong seniority position. It is found that the seniority of the above candidates in the cadre of L.D.Clerk are assigned without following the rules stipulated in the G.Os read as 07 to 11 above.

In this circumstances it was provisionally decided to reassign the rank number of the 26 incumbents in accordance with the rules stipulated in the G.Os read as 08 to 11 above as detailed in Annexure A appended herewith. Inviting appeals from the aggrieved persons were issued vide notice 12th read above.

No genuine appeals are seen received in this regard. Under the circumstances, the above proposal to reassign the rank number of the 26 incumbents mentioned in the notice is finalised and the details are shown in Annexure – A.

The promotion to the above incumbents to the cadre of U.D.Clerk will be re-examined and the seniority in the cadre of U.D.Clerk will also be fixed accordingly.

The seniority list of L.D.Clerks vide paper 1st to 5th above are modified to this extent.
