As per letters referred 1st to 8th , the appeals in respect of 8 Nursing Staff regarding rectification of the anomalies occurred in the seniority list of, Staff Nurse Grade-II (1990-2002), Staff Nurse Grade-II (2003-2010) published vide orders referred 10th & 11th respectively have been forwarded . The points raised in the above said appeals and their service particulars have been examined in detail with all connected service details and found certain anomalies, such as non inclusion of name, non consideration of Inter District Transfer and Leave Without Allowances etc. Further, on verification of this office records, similar anomalies were also noted in the assignment of seniority position of 5 other nurses.

Accordingly vide paper read as 9th above, a notice has been issued from this office intimating the provisional decision to rectify the anomalies occurred in the seniority list and also inviting appeals if any regarding the same. No genuine appeals were received in this regard.

In these circumstances, the provisional decision to rectify the anomalies occurred in the said seniority lists are finalized as detailed in the Annexure 'A' appended herewith.
