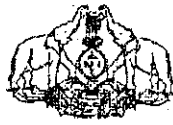

ORDER

Dr.B.Moorthy Raj while working as Deputy Superintendent at Mental Health Center, Thiruvananthapuram had applied for Leave Without Allowances for 2 years from 15.08.2012 to study at an institution abroad and after that he proceeded on leave without obtaining 'No Objection Certificate' or permission from the concerned authorities. Hence he was on unauthorized absence from duty with effect from 15.08.2012. Government initiated disciplinary action against the Medical Officer and Memo of Charges were served on the Medical Officer vide the letter read as 1st paper above.

2. The Medical Officer as per the representation read as 2nd paper above has requested to permit him to rejoin duty with effect from 16.08.2016. The Director of Health Services has forwarded his request to Government for consideration as per the letter read as 3rd paper above.

3. Government have examined the matter in detail and are pleased to permit Dr.B.Moorthy Raj to rejoin duty as Assistant Director in Health Services Department, **pending disciplinary action** for the offence of his unauthorized absence.

On rejoining duty, Dr.B.Moorthy Raj is posted as Superintendent, Taluk Headquarter Hospital, Nedungandam, Idukki.

4. Dr.B.Moorthy Raj is allowed 10 days time from the date of issue of order to rejoin duty, failing which action will be taken to remove him from service observing procedures as per rules.


