In the Pay Revision Order read above, the percentage based Higher Grade is sanctioned to Senior Superintendent/Lay Secretary and Treasurer and Inter changeable posts as per Special Rules, that is 25% of the total strength. Accordingly the strength of upgraded posts have been fixed as 36 Numbers. There are 27 employees now working in the cadre of Senior Superintendent/Lay Secretary and Treasurer and Inter Changeable posts as per Special Rules are enjoying the percentage based higher Grade. As such 9 more officers in the above cadre has to be sanctioned percentage based higher grade in the scale of pay of Rs.40,500-85,000(Revised). The details are shown below.
