Sub:- Estt - HSD - Provisional appointment of Nursing Tutors from qualified Head Nurses and Staff Nurses - Sanctioned - Orders issued

ORDER NO.EE2 - 38607/10/DHS DATED: 22.11.2016

Government vide order read 1st above, have created 19 post of Nursing Tutor in the scale of pay Rs.18740-33680 (pre revised) under new service procedure.

There are 8 more vacancies of Nursing Tutors due to retirement termination/NJD reported.

The Seniority list of incumbents in Head Nurse, Staff Nurse category eligible to be posted as Nursing Tutors through by transfer promotion have been published vide orders read 5th. Certain appeals for including names are still pending regarding the said seniority list. The said appeals will be scrutinized as per rules by the appeal committee and a final decision will be taken in this regard.

Among the above said 27 vacancies, available, 5 have already been reported to PSC for direct recruitment, as per the prescribed ratio. Accordingly, 22 vacancies are now available for appointment by transfer.

Since appeals are pending, it has been decided to effect appointments to 19 vacancies only at present and 3 vacancies will be set aside for the consideration of appeals, Appointment to these 3 vacancies will be made after finalization of appeals by the appeal committee.

According to the qualification and method of appointment prescribed for the post of Nursing Tutors vide orders read 3rd and 4th the Head Nurses and Staff Nurses Grade I in the list appended are qualified to hold the post of Nursing Tutors in Government Schools of Nursing and JPHN Training centres under this department. Therefore they are provisionally appointed as Nursing Tutors in the scale of pay Rs.18740-33680 (pre revised) and posted to the institutions noted against their names in the list appended.

The heads of the institution are directed to relieve the incumbents without waiting for substitute with direction to report for duty immediately.

The candidates who are included in this orders should produce the original certificate regarding proof of qualification, date of birth, certificate of registration in Kerala Nursing Council before the Principal of the concerned School of Nursing / JPHN Training Centres at the time of joining duty.

The Principal of the School of Nursing/Junior Public Nurse Training Centre should verify the original Certificate produced by the Candidates at the time of their joining duty and satisfy themselves that the appointees possess any one of the following Qualifications.

- a. M.Sc/BSc Nursing Degree in Nursing (Basic or Post Basic) from a recognised University and recognized by the Indian Nursing Council.
- b. Diploma in Nursing education and Administration from a recognised university and recognised by the Indian Nursing Council.
- c. Registration with Kerala Nurses and Midwives council as Nurses and Midwives.

No extension of joining time will be allowed to the candidates.

The report of joining duty and relief and the report of transfer of charge should be forwarded to this office promptly through the District Medical Officers of Health concerned.

The candidates are placed on probation for a total period of one year duty with in a continuous period of two years.

All the candidates should pass the Accountant test for Executive Officers (Kerala) or Account Test (Lower) for declaration of probation.

If there is any change in the present station of the incumbents which are mentioned in column 2 in this order, the head of the institution concerned should relieve the incumbents with direction to report for duty in the station to which they are posted as Nursing Tutor and the fact may be reported to this office.

If any incumbents who are on Leave Without Allowance or Unauthorised Absence or Under Suspension need not be relieved and the fact should be reported to the undersigned without fail.

All the working arrangements/Stop gap arrangements in the cadre of Nursing tutors made earlier are hereby cancelled.

The incumbents who are included in the list appended may download a copy of this order published in the official website of the Director of Health Services and may use as authenticated copy for relief and joining duty.


