The concerned District Medical Officer of Health should issue necessary posting orders to the incumbents. They should be relieved off their duties only after receipt of posting orders from the District Medical Officers (Health). The Head of the institution should verify the documents to prove the qualification of the incumbents before permitting them to join duty. If any discrepancy is noted, they should not be allowed to join duty and the fact should be reported to this office immediately. The incumbents shall be on probation for a total period of one year on duty within a continuous period of two years from the date of joining duty. The holder of Sanitary Inspector Course Certificate or its equivalent should have to undergo the in service multipurpose workers training course to become fully qualified for the post of Junior Health Inspector Grade-II. The above instructions and conditions should be noted in the posting order.

The district allotted to the incumbents vide this order will be reviewed during general transfer and normal transfer as all the transfers are withheld due to State Assembly Election 2016. No appeals will be tolerated in this regard from the incumbents.
