The Concerned District Medical Officer of Health should issue necessary positing orders to the incumbents. They should be

relieved of their duties only after receipt of posting orders from the District Medical Officers (Health) where they are posted. The Head of the institution should verify the documents to prove the qualifications of the incumbent before permitting them to join duty. If any discrepancy is noted, they should not be allow to join duty and the fact should be reported to this office immediately. The incumbent shall be on probation for a total period of one year on duty within a continuous period of two years from the date of joining duty. The holder of Sanitary Inspector Course Certificate or its equivalent should have to undergo the in service multipurpose workers training course to become fully qualified for the post of Junior Health Inspector Grade II. The above instructions and conditions should be noted in the posting order.

This by transfer appointment to the cadre of Junior Health Inspector Grade II is state wise and will not come under the purview of Inter District Transfer norms will be come under state wise.

The incumbents are authorised to use the print out of this order published in the official website of Directorate of Health Services for official purpose. The date of relief and joining duty should be reported to this office promptly.
