ORDER

The State Government had instituted six Awards each consisting of a citation and cash award to Best Doctors every year with a view to identify aninent members of the Medical fraternity and to recognize their services to the community. The award is being distributed on 1st July of every year which is the birthday of Dr.B.C.Roy and also being observed as Doctors Day.

- 2) The Award Committee for the selection of Best Doctor Award in Modern Medicine held on 11.06.2004 recommended certain modifications in the existing guidelines for the selection of Doctors for Best Doctor Award. Government after having examined these recommendations are pleased to revise and prescribe the following guidelines for the selection of the Best Doctors superceding all the existing government Orders in the matter.
 - (i) These guidelines are called guidelines for determining the Best Doctors State Award and the mode of distribution of the prize money among Best Doctor in Modern Medicine in Medical Education Department, Health Services Department, doctors working in Dental Specialties, Insurance Medical Service Department, Doctors in Private Sector, Medical Officers working in Corporations, Municipalities, Cooperative Hospitals, Regional Cancer centre, Sree Chitra Institute of Medical Science and Technology etc.
 - (ii) Date of award distribution ceremony will be the 1st July of every calendar year.
 - (iii) Cash awards as detailed below will be given to the winners in additional citation.

Rs.10,000/-State Award for the Best Doctor from the Health Service Repartment a. Fs.10,000/-State Award for the Best Doctor from the Insurance Medical Service b. Rs.10,000/-State Award for the Best Doctor from the Medical Education Service Ö. Rs.10,000/- -State Award for the Best Doctor working in Corporation Hospitals, RCC, d. Sree Chitra Institute of Sciences and Technology State Award for the Best Doctor Dental : Rs.10,000/-Ċ. Specialtites State Award for the Best Doctor in : Rs.10,000/-

4) As regards the mode of inviting applications for selection application by individual doctors, nominations from Associations/Voluntary organizations or department will be entertained.

- 5) There should be a minimum of at least five applications in each category. The applications will be forwarded by the concerned Department/Association with their remarks. A preliminary scrutiny of the applications will be done by the Committee consisting of Joint Director of Medical Education/Additional Director of Health Services (PH)/Secretary/Nominee of the State Organization.
- 6. Individual applications if any received by Government/Director of Health Services/Director of Medical Education will be forwarded to the Screening Committee.
- 7) 15th January every year is fixed as a cut off date for calling applications for award. Last date of receiving application is March 15th. The Director of Health Services will make necessary arrangement to give wide publicity through three vernacular dailies in the State (on English and two Malayalam) for the invitation of applications for the selection of the Best Doctors in all the 6 categories. The screening committee will scrutinize the applications before May 15th and the applications will be forwarded to the Secretary to Government, Health & Family Welfare Department. The award committee will be convened by June 15th. All the applications should contain 10 copies each of all the documents submitted by the applicant. The Director of Health Services will make available necessary performance for selection of Best Doctors. Co-ordination of the work will be at the level of Director of Health Services.
- alone will be considered for the award. When Doctors in the private sector are considered for award, those who have completed 10 years of private practice in Kerala alone are eligible. Doctors who have retired from Government service will also be considered if they complete 10 years of service in private sector after retirement. In other words he/she should not have worked in any Government departments for the last 10 years from the date of the notification. Doctors who are convicted of criminal offences involving professional misconduct, moral turpitude and departmental disciplinary actions shall not be considered for this award.
 - 9) The following criteria will be adopted for considering applications:

next five years from the date of concerned award and in respect of Government doctors, stringent, disciplinary action will be taken against them as per the provisions in the KCS (CO & A) Rules 1960 on the charge of trying to cheat Government.

- 15) Government will be at liberty to reconstitute the structure of the Award Committee or co-opt members and review the whole system every two years from the date of each award.
- 16) The function of award distribution will be arranged strictly on the basis of protocol instructions and with the active co-operation of the concerned Associations in the Department.
